



How to open a CDS account via the CSE Mobile App


USER GUIDE

There are three main steps to follow to create a CDS account,


1. Download and install the CSE mobile App
2. Create CSE account
3. Open the CDS account

1. How to download the CSE mobile App?

Step 01 - Go to the App store (IPhones) or Play store (Android) of your mobile and search for the “CSE Mobile App”





Step 02 – Download and install the App to your mobile


2. How to create the CSE account?




Step 01 – Open the CSE App and select “Our Services”, then select “My CSE”.

Step 02 – Select “Register”




Step 03 – Select “Create Your Account”




Step 04 – Enter your email address and click “Next”



Step 05 – Enter a password for your CSE account and click “Next”





Step 06 – Check your email account for the OTP (One Time Password) to complete the next step.



Step 07 – Enter the OTP and click “Verify”


Step 08 – If you get this error message when verifying the OTP, wait for the countdown to complete and click the “Resend Code” button and repeat step 06 and 07.



Step 09 – Check your Mobile for the OTP for the mobile number verification.




Step 10 – Enter the OTP received to your mobile via SMS and click “Verify”.



Step 11 – Click on “Link Your Authenticator” button.



Step 12 – Select your authentication type and follow the steps to create an authenticator.



Step 13 – You have now created the CSE account. Check the top left corner of “Our Services” window for the account name.


3. How to open the CDS account?

Selfie


Kindly upload a selfie taken at the time of completing the application. It should be clear, in focus & in colour. Photo shouldn't contain any other objects or people. It should be a full-face & shoulder shot squarely facing the camera. Do not wear sunglasses or tinted glasses. You can wear other glasses if you need to, but your eyes must be visible without any glare or reflection

Step 09 – Upload a nice selfie of yours.




Step 10 – Take pictures of both sides of your NIC and upload.

Step 11 – Take a picture of your bank book/ bank statement.





Step 12 – Read the terms and conditions and click each check box.





Step 13 – Click on “I AGREE & DECLARE” button at the end of “Terms & Conditions page.”

Step 14 – Click on “Authorize” and enter your authenticator (Touch id or Password).



Step 15 – Congratulations! You have successfully submitted the online application form.

After completion and submission of CDS form, the CDS and stockbroking firm will proceed on opening your account. An email will be sent with the confirmation of the account opening.

It will take 2 to 3 working days to open a CDS account, due to the prevailing situation.
